Section 1

Applications Received

Inspection of licence applications can be requested free of charge by anybody who holds statutory Objector status. Inspection can take place, at the Traffic Area, by any person who carries written authority to act in that capacity.

Alternatively, copies of weekly publications can be obtained on payment of either an annual subscription of £15.00 or 60 pence for individual publications. Details can also be viewed by visiting the VOSA website at www.vosa.gov.uk

Objections against published applications may be made in writing by a Chief Officer of Police, a local authority, a planning authority or a prescribed trade union or association within 21 days after publication of this booklet. Objections must be made either on the grounds that any of the requirements listed in Section 13 of the Goods Vehicles (Licensing of Operators) Act 1995 are not met and/or that a nominated operating centre will be unsuitable for use as such. A copy of the Objection must be sent by the objector to the applicant at the same time that it is sent to the Traffic Commissioner. The onus of proof in terms of the grounds on which an Objection is lodged lies with the objector.

Classification of operator licences – there are three licence categories:-

- A **Restricted (R)** licence authorises the use of a goods vehicle on public roads in Great Britain for the carriage of the licence holder's own goods in the course of his trade or business. The licence holder cannot carry goods for other people for hire or reward;
- A **Standard National (S/N)** licence allows the licence holder to carry both his own goods and goods for other people for hire or reward, on public roads in Great Britain. He can also carry his own goods on journeys abroad;
- A **Standard International (S/I)** licence allows the licence holder to carry both his own goods and goods for other people for hire or reward. These activities can be undertaken both in Great Britain and on international journeys.

Section 3

Schedule 4 Applications

Schedule 4 to the Goods Vehicles (Licensing of Operators) Act 1995 allows, in certain situations, the transfer of operating centres from one existing licence to either another existing licence or as part of a new licence application. A range of qualifying criteria have to be met, with approval at the Traffic Commissioner's discretion. An important consideration in the process is any environmental history relating to the subject operating centre or any potentially adverse environmental impact resulting from the transfer. OK0166336 SN Balfour Beatty Group Ltd: Following Transport Tribunal Decision of Appeal 2005/203 to remit the matter back to the Traffic Commissioner (Application & Decision 3683 refers) the Traffic Commissioner decided on 27 April 2006 to grant Hoo Junction Depot, Higham, Kent as an operating centre to authorise 2 vehicles with 3 conditions and 7 undertakings attached:

Conditions

- (a) that one of the authorised vehicles shall not exceed 7.5 tonnes and that one of the authorised vehicles shall not exceed 17.5 tonnes;
- (b) that there shall be no movements by authorised vehicles to or from the operating centre other than between 0700 and 1630 (Monday to Friday) with no movements on Saturdays, Sundays or bank holidays except in cases of railway emergencies when details of any emergency and any associated vehicle movements will be recorded and made available to the Traffic Commissioner on request;
- (c) that no maintenance or refuelling will take place at the site;

Undertakings

- (d) that (except in cases of emergency) the vehicles will not make on average over five days more than four movements each per day (Monday to Friday) (ie a total of 20 movements);
- (e) that no vehicle will make more than six movements in any one day;
- (f) that a log of all movements by authorised vehicles will be maintained, and will be made available for inspection by the residents of Canal Road;
- (g) that two designated drivers will receive training for and be monitored for driving with sensitivity in Canal Road;
- (h) that the Company's vehicles will not exceed 10 mph in Canal Road;
- (i) that the Company will carry out periodic reviews of practices at the Site to see if vehicle movements can be reduced;
- (j) that details of the Company's vehicles used at Hoo Junction will be provided to the residents.
