**South Eastern and Metropolitan Traffic Area - Change of Postal Address**  
**from**  
**22 January 2007 for Goods Vehicle Operator Licensing.**

Following a review by VOSA of its operations, the processing of Operator licence applications will be moving from the regional Traffic Area Offices to a central licensing unit in Leeds.

This note contains important information about forthcoming changes to the Postal Address of the South Eastern and Metropolitan Traffic Area (SEMTA). The changes for SEMTA will take place during the week of 22 January 2007.

The aim of Centralisation is to deliver a more consistent handling of applications and an improved service with one correspondence address for all operator licensing.

The central processing unit will support the existing Traffic Commissioners and their role as the independent Licensing Authority will not be affected.

Decisions on SEMTA licences will continue to be made in the local Office of the Traffic Commissioner. Traffic Area boundaries will remain unchanged and Public Inquiries will continue to be held locally.

## **Section 3**

### **Schedule 4 Applications**
