CHANGES TO THE MINIMUM FINANCIAL STANDING LEVELS REQUIRED BY HOLDERS OF HGV AND PSV OPERATORS' LICENCES

The Department for Transport has given notice of revisions to the minimum levels of financial backing required by holders of goods and PSV operators' licences. This is an EU requirement.

This will affect holders of standard national, standard international and restricted licences. The most significant change is that the holders of standard national licences will now have to meet the same levels of financial standing as standard international licence holders. The original Directive had contained a derogation allowing for lower levels for national only operators. The Department for Transport has now concluded that under EU legislation the financial standing minimum should be the same for both national and international operators. The Traffic Commissioners retain their discretion to set the financial standing levels for restricted licence holders. They propose to increase this amount in line with increases for standard international licence holders.

The revised figures are set out below and are based on the Euro exchange rate on 1 October. They will come into force on 1 January 2005 and will remain in place for five years.

Notes

1. The users of goods vehicles over 3.5 tonnes and public service vehicles must hold an operator's licence. The operator licensing system is administered by the statutorily independent Traffic Commissioners.
2. Licence holders must satisfy the Traffic Commissioner that they have available sufficient finances to safely maintain their vehicles and to properly administer the business. The required levels are set in Euros by EU Directive 96/26/EC, as amended by Directive 98/76/EC.
3. Non-Euro participating Member States are required to review the value of the Euro in their currencies every five years. The exchange rates to be applied are those on the first working day of October and come into

Section 1

Applications Received

Inspection of licence applications can be requested free of charge by anybody who holds statutory Objector status. Inspection can take place, at the Traffic Area, by any person who carries written authority to act in that capacity.

Alternatively, copies of weekly publications can be obtained on payment of either an annual subscription of £** or ** pence for individual publications. Details can also be viewed by visiting **the VOSA website** at www.vosa.gov.uk

Objections against published applications may be made in writing by a Chief Officer of Police, a local authority, a planning authority or a prescribed trade union or association within 21 days after publication of this booklet. Objections must be made either on the grounds that any of the requirements listed in Section 13 of the Goods Vehicles (Licensing of Operators) Act 1995 are not met and/or that a nominated operating centre will be unsuitable for use as such. A copy of the Objection must be sent by the objector to the applicant at the same time that it is sent to the Traffic Commissioner. The onus of proof in terms of the grounds on which an Objection is lodged lies with the objector.

Classification of operator licences – there are three licence categories:-

- A **Restricted (R)** licence authorises the use of a goods vehicle on public roads in Great Britain for the carriage of the licence holder's own goods in the course of his trade or business. The licence holder cannot carry goods for other people for hire or reward;
- A **Standard National (S/N)** licence allows the licence holder to carry both his own goods and goods for other people for hire or reward, on public roads in Great Britain. He can also carry his own goods on journeys abroad;
- A **Standard International (S/I)** licence allows the licence holder to carry both his own goods and goods for other people for hire or reward. These activities can be undertaken both in Great Britain and on international journeys.

Section 3

Schedule 4 Applications

Schedule 4 to the Goods Vehicles (Licensing of Operators) Act 1995 allows, in certain situations, the transfer of operating centres from one existing licence to either another existing licence or as part of a new licence application. A range of qualifying criteria have to be met, with approval at the Traffic Commissioner's discretion. An important consideration in the process is any environmental history relating to the subject operating centre or any potentially adverse environmental impact resulting from the transfer. Legislation prevents any statutory objection against the Schedule 4 element of an application.

New Applications (Section 3.1): where the Traffic Commissioner has given a direction that the provisions of paragraph 2 of Schedule 4 shall apply, objections may only be lodged against the published application under Section 12(1)(a) of the 1995 Act, disregarding the suitability of the operating centre for use as such by the applicant as set out in Section 13(5)(d) of the Act;
