## **IMPORTANT INFORMATION**

### **Western Traffic Area - Change of Postal Address from 7 August 2006 for Goods Vehicle Operators and Public Service Vehicle Operators.**

Following a review by VOSA of its operations, the processing of Operator licence applications will be moving from the regional Traffic Area Offices to a central processing unit in Leeds.

**This note contains important information about forthcoming changes to the Postal Address of the Western Traffic Area. The changes for the Western Traffic Area will take place from 7 August 2006.**

Centralisation will deliver more consistent handling of applications and an improved service with one correspondence address for all operator licensing.

The central processing unit will support the existing Traffic Commissioners and their role as the independent Licensing Authority will not be affected. Licences will continue to be issued by the Traffic Commissioners with the central unit processing applications for licences under each Traffic Commissioners' delegated authority.

Traffic Area boundaries will remain unchanged and Public Inquiries will continue to be held in the area of each Traffic Commissioner.

## Section 1

### Applications Received

**Inspection of licence applications** can be requested free of charge by anybody who holds statutory Objector status. Inspection can take place, at the Traffic Area, by any person who carries written authority to act in that capacity.

Alternatively, copies of weekly publications can be obtained on payment of either an annual subscription of £15 or 60 pence for individual publications. Details can also be viewed by visiting **the VOSA website at [www.vosa.gov.uk](http://www.vosa.gov.uk)**

**Objections against published applications** may be made in writing by a Chief Officer of Police, a local authority, a planning authority or a prescribed trade union or association within 21 days after publication of this booklet. Objections must be made either on the grounds that any of the requirements listed in Section 13 of the Goods Vehicles (Licensing of Operators) Act 1995 are not met and/or that a nominated operating centre will be unsuitable for use as such. A copy of the Objection must be sent by the objector to the applicant at the same time that it is sent to the Traffic Commissioner. The onus of proof in terms of the grounds on which an Objection is lodged lies with the objector.

**Classification of operator licences** – there are three licence categories:-

- A **Restricted (R)** licence authorises the use of a goods vehicle on public roads in Great Britain for the carriage of the licence holder's own goods in the course of his trade or business. The licence holder cannot carry goods for other people for hire or reward;
- A **Standard National (S/N)** licence allows the licence holder to carry both his own goods and goods for other people for hire or reward, on public roads in Great Britain. He can also carry his own goods on journeys abroad;
- A **Standard International (S/I)** licence allows the licence holder to carry both his own goods and goods for other people for hire or reward. These activities can be undertaken both in Great Britain and on international journeys.

## **Section 3**

### **Schedule 4 Applications**

Schedule 4 to the Goods Vehicles (Licensing of Operators) Act 1995 allows, in certain situations, the transfer of operating centres from one existing licence to either another existing licence or as part of a new licence application. A range of qualifying criteria have to be met, with approval at the Traffic Commissioner's discretion. An important consideration in the process is any environmental history relating to the subject operating centre or any potentially adverse environmental impact resulting from the transfer. Legislation prevents any statutory objection against the Schedule 4 element of an application.

**New Applications (Section 3.1):** where the Traffic Commissioner has given a direction that the provisions of paragraph 2 of Schedule 4 shall apply, objections may only be lodged against the published application under Section 12(1)(a) of the 1995 Act, disregarding the suitability of the operating centre for use as such by the applicant as set out in Section 13(5)(d) of the Act;

**Variation applications (Section 3.2):** where the Traffic Commissioner has given a direction that the provisions of paragraph 4 of Schedule 4 shall apply, objections may again only be lodged against the published application under Section 12(1)(a) of the 1995 Act **unless** that transfer can be accommodated without any overall increase in the existing overall vehicle/trailer authorisation on the receiving licence, in which case there is no statutory requirement to publish details of that application. **Section 3.3** does however detail any such applications in order that interested parties are made aware of changes to authorised operators at listed operating centres
