This is non-refundable and payable in full at the time the application is sent to the TAO. (There is no charge for applications which seek only to upgrade a licence eg from restricted to standard national.)

FEE PAYABLE FOR THE ISSUE OF A LICENCE	£263
---	-------------

This is non-refundable and payable in full after an application for a licence has been granted. Its cover lasts for 5 years.

CHARGE FOR THE CONTINUATION OF AN EXISTING LICENCE	£263
---	-------------

This is non-refundable and payable in full every 5 years, the first payment becoming due in the month leading up to the 5th anniversary of the issue of the licence.

VEHICLE FEES

Vehicle fees are charged for each vehicle specified by registration mark on a licence. When an application for a new licence is first granted, or before a licence is continued, the operator can choose to pay the vehicle fees either 5 years in advance, or on an annual basis.

Vehicle fees are payable after the grant of an application for a licence or variation of a licence, or at the same time as the continuation fee. Yearly payments are due each year on the anniversary of the end of the month preceding the month in which the licence was issued.

Section 1

Applications Received

Inspection of licence applications can be requested free of charge by anybody who holds statutory Objector status. Inspection can take place, at the Traffic Area, by any person who carries written authority to act in that capacity.

Alternatively, copies of weekly publications can be obtained on payment of either an annual subscription of £15 or 60 pence for individual publications. Details can also be viewed by visiting the TAN website at www.tan.gov.uk

Objections against published applications may be made in writing by a Chief Officer of Police, a local authority, a planning authority or a prescribed trade union or association within 21 days after publication of this booklet. Objections must be made either on the grounds that any of the requirements listed in Section 13 of the Goods Vehicles (Licensing of Operators) Act 1995 are not met and/or that a nominated operating centre will be unsuitable for use as such. A copy of the Objection must be sent by the objector to the applicant at the same time that it is sent to the Traffic Commissioner. The onus of proof in terms of the grounds on which an Objection is lodged lies with the objector.

Classification of operator licences – there are three licence categories:-

- A **Restricted (R)** licence authorises the use of a goods vehicle on public roads in Great Britain for the carriage of the licence holder's own goods in the course of his trade or business. The licence holder cannot carry goods for other people for hire or reward;
- A **Standard National (S/N)** licence allows the licence holder to carry both his own goods and goods for other people for hire or reward, on public roads in Great Britain. He can also carry his own goods on journeys abroad;
- A **Standard International (S/I)** licence allows the licence holder to carry both his own goods and goods for other people for hire or reward. These activities can be undertaken both in Great Britain and on international journeys.

Schedule 4 Applications
