PSV Operator Licensing

Inspection of licence applications can be requested under the provisions of Regulation 4 of the Public Service Vehicles (Operators' Licences) Regulations 1995 by anybody who holds statutory Objector status. Applications may be inspected free of charge at the Traffic Commissioner's office by any person who carries written authorisation to act in that capacity. Alternatively, copies of weekly publications can be obtained by either an annual subscription of £91 or £3.50 for individual publications. Details can also be viewed by visiting **the VOSA website at www.vosa.gov.uk**

Objections against applications for licences may be made in writing by a Chief Officer of Police or local authority within 21 days after the date on which notice of an application is published in Notices and Proceedings. Objections must be made on the grounds that one or more of the requirements mentioned in Section 14(1) and (3) of the Public Passenger Vehicles Act 1981 are not satisfied in relation to the application. A copy of the objection must be sent by the Objector to the applicant at the same time that it is sent to the Traffic Commissioner. The onus of proof in terms of the grounds on which an objection is lodged lies with the objector. There is no right of objection against an application for a special licence submitted under Section 12 of the Transport Act 1985.

Classification of Operator Licences - There are four classes of licence: -

- A **Standard International (S/I)** licence authorises the use of any description of public service vehicle on both National and International operations;
- A **Standard National (S/N)** licence authorises the use of any description of public service vehicle on National operations;
- A **Restricted licence (R)** authorises the use of (a) public service vehicles not adapted to carry more than eight passengers and (b) those not adapted to carry more than sixteen passengers when used otherwise than in the course of a business of carrying passengers or by a person whose main occupation is not the operation of public service vehicles adapted to carry more than eight passengers;
- A **Special Restricted (SR)** licence under Section 12 of the Transport Act 1985 is granted to the holder of a taxi licence to enable local services to be operated.

Appeals in connection with PSV Operator Licences must be lodged with the Transport Tribunal, Procession House, 55 Ludgate Hill, London EC4M 7JW not later than 28 days after the date of the letter conveying the Traffic Commissioner's (or Deputy Traffic Commissioner's) decision. A copy of the appeals booklet is available from the Traffic Area Office on request. Appellants can alternatively obtain guidance on lodging appeals by visiting **the VOSA website at www.vosa.gov.uk**

Registration Of Local Bus Services

When an application is sent to the Traffic Area Office, a copy of all application forms and supporting documents must also be sent to each of the County Councils and Unitary Authorities in whose area the service will operate. Failure to do so may delay acceptance of that application.

Some of the periods of notice applicable before the operation of registered services, including variations or cancellations, are at the discretion of the Traffic Commissioner. In such cases the application must be accompanied by a written explanation of why a short notice period is required.

Any registration may be inspected at the office of the Traffic Commissioner during public business hours and copies of registrations can be sent by post or fax to any interested party upon prior receipt of a written request together with a fee of £3.00 per copy for posted copies or £5.00 per copy for faxed copies.

The Operator's Licence

(i). In regard to the unsatisfactory maintenance investigation, the company is given a formal warning in regard to its conduct subject to a request to VOSA to carry out a further maintenance investigation within the next 12 months.

(ii). In regard to the matters arising from the Traffic Examiner's investigation, action is taken against the Operators Licence pursuant to Section 17(2)(d), and (3)(a) of the Public Passenger Vehicles Act 1981 varying the condition attached under Section 16 (1) so as to specify that no more than ten vehicles may be used on the operator's licence at any one time.

(iii). In order to give the operator time to make alternative arrangements in regard to contractual arrangements already entered into, implementation of this decision is deferred until 2359 on 3 December 2006.

(iv). A further investigation by VOSA staff into the company's compliance with its undertaking in respect of drivers hours and tachograph regulations is requested for the operating months of April and May 2007. It is also requested that that any report in relation to that investigation should indicate the extent to which related disciplinary procedures are implemented in respect of any detected offences by drivers.

(v). Whilst an unsatisfactory report from the Traffic Examiner is likely to result in a further Public Inquiry into the operator's conduct, I see no reason why a satisfactory report should not lead to a successful application by the operator to restore the current authorisation should that be desired and providing all other necessary criteria are then met.

Repute of the Transport Managers

(i). On the basis of the action taken by Mr Keith Davies to address the issues both in regard to maintenance and tachographs, I find he has retained his good repute as a Transport Manager, albeit by a narrow margin.

(ii). Mr Mark Davies stated that he was responsible for the running of the office. Beyond that he appears to have little day-to-day involvement in the executive management of the company. As office manager, the failure to collect, collate and file tachograph records appears to be a matter over which he should have had effective control and in respect of which he exercised none. Whilst accepting liability for the company's failings, his only real explanation was to blame it on the driver who had committed the majority of offences and he did not appear to recognise that the detection of those offences as and when they occurred was wholly the responsibility of the Transport Managers and directors of the business. That is inconsistent with the duty of a nominated Transport Manager to exercise effective and continuous control over such matters. I therefore find Mr Mark Davies has lost his good repute as a Transport Manager and may not continue to act in that capacity.
