Section 2 – PSV Operator Licensing

Inspection of licence applications can be requested under the provisions of Regulation 4 of the Public Service Vehicles (Operators' Licences) Regulations 1995 by anybody who holds statutory objector status. Applications may be inspected free of charge at the traffic area office in Leeds by any person who carries written authorisation to act in that capacity.

Objections against applications for licences must be made in writing by a Chief Officer of Police or by a local authority within 21 days of the date on which notice of an application is published in Notices and Proceedings. Objections must be made on the grounds that one or more of the requirements mentioned in Sections 14(1) and (3) of the Public Passenger Vehicles Act 1981 are not satisfied in relation to the application. A copy of the objection must be sent by the objector to the applicant at the same time that it is sent to the Traffic Commissioner. The onus of proof in terms of the grounds on which an objection is lodged lies with the objector. There is no right of objection against an application for a special licence submitted under Section 12 of the Transport Act 1985.

Classification of Operator Licences – There are four classes of licence:

- A **Standard International (SI)** licence authorises the use of any description of public service vehicle on both national and international operations;
- A **Standard National (SN)** licence authorises the use of any description of public service vehicle on national operations;
- A **Restricted licence (R)** authorises the use of:
 - a) public service vehicles not adapted to carry more than eight passengers; and
 - b) those not adapted to carry more than sixteen passengers when used otherwise than in the course of a business of carrying passengers or by a person whose main occupation is not the operation of public service vehicles adapted to carry more than eight passengers;
- A **Special Restricted (SR)** licence, issued under Section 12 of the Transport Act 1985, authorises the holder of a taxi or private hire vehicle licence to operate local services.

Appeals in connection with PSV Operator Licences must be lodged with the Upper Tribunal – Administrative Appeal Chamber (Transport), 7th Floor, Victory House, 30-34 Kingsway, London, WC2B 6EX not later than 28 days after the date of the letter conveying the Traffic Commissioner's (or Deputy Traffic Commissioner's) decision. New Undertaking: Limousines and novelty type vehicles are not to be operated under this operator's licence.

Small vehicle undertakings:

(a) The operator will advise the traffic commissioner of the type and registration number of vehicles used under that licence, and will advise of any changes — section 20(3) of the Public Passenger Vehicles Act 1981

(b) The operator will send in the original V5 document to the traffic commissioner.

(c) Each small vehicle to be used under the licence will have a V5 registration book, and the operator must possess and produce, when asked to do so, a document confirming this.

(d) Each small vehicle will receive a full safety inspection (maximum every 10 weeks) in premises suitable for the vehicle to ensure that its roadworthiness is maintained. Records of all inspections must be kept in accordance with the Guide to Maintaining Roadworthiness.

(e) At no time will the small vehicle carry more than eight passengers.

(f) The operator will at all times comply with the legislation in respect of the charging of separate fares and retain 12 months' evidence of this compliance for each journey-

(g) Drivers of small vehicles will carry with them documentary evidence that separate fares have been charged for the current journey.

(h) The operator will comply with sections 2 and 6 of the Transport Act 1985 with regard to local service registration and must be able to show compliance with these sections to VOSA, on request. This will include proof of payment of separate fares and either:

- Proof that passengers have travelled more than 15 miles. This will usually be, evidenced by showing postcodes; or

- Proof that the service is an excursion or tour and falls outside the definition of a local service.

(i) The operator will not use a vehicle that does not meet the ECWVTA standards or British construction and use requirements.

(j) The operator will not use any vehicle where the traffic commissioner considers its use to constitute an illegal practice such as 'dry hiring' or purporting to operate under specious and irrelevant authority such as reference to schedule 6 or section 6 (which usually refers to construction and use provisions to allow the driving of a vehicle for private use — as opposed to hire or reward), in an effort to circumvent the operator licensing requirements.

(k) If the operator seeks to use the 'tours and excursions' exception. to the 15 mile rule, again this should be evidenced and readily available to VOSA. This may be on the booking form. The limits of the 'tours & excursions' exemption will also be fully understood by the operator, for example it cannot be available for more than six weeks.

(l) The operator or driver will not break the alcohol laws.

(m) Limousines or novelty vehicles are not to be operated under this operator licence.

Before an application is sent to the Traffic Commissioner, the operator must inform the relevant local authorities/SPT 14 days before submission. The operator will be required to demonstrate to the Commissioner that this requirement has been met before the application can be accepted. Until such times as revised application forms are available operators should enclose a copy of the letter sent to the local authorities/SPT with the application to the Traffic Commissioner.

Some of the periods of notice applicable before the operation of registered services, including variations or cancellations, are at the discretion of the Traffic Commissioner. In such cases the application must be accompanied by a written explanation of why a short notice period is required along with, if appropriate, a letter from the local authorities/SPT indicating support.

Any registration may be inspected at the office in Edinburgh during public business hours. Copies of registrations can be sent by post or fax to any interested party upon prior receipt of a written request together with a fee of £3.00 per copy for posted copies or £5.00 per copy for faxed copies.

Section 4 – Traffic Regulation Conditions

Section 4.1 – Requests

Reference TRC15 – Request to vary the existing Traffic Regulation Condition in Paisley Town Centre.

The Traffic Commissioner has received from the Head of Roads and Transportation, Renfrewshire Council, Renfrewshire House, Cotton Street, Paisley, PA1 1LL a request under Section 7 of the Transport Act 1985 to determine a variation of the Traffic Regulation Condition currently in place in Paisley Town Centre to provide operators of local bus services with a facility to enable recovery time to be taken.

The proposed variation to TRC15 is as follows:

This Traffic Regulation Condition applies to the following streets within the Paisley Town Centre area:

Causewayside Street, Orchard Street, Johnston Street, Bridge Street, Cotton Street, Gauze Street, St Mirren Street, High Street, New Street, Canal Street, Gordon Street, Mill Street, Lawn Street, Silk Street, Incle Street, Old Sneddon Street (between Moss Street and Smithhills Street), New Sneddon Street, Central Road, Smithhills Street, Weir Street (between Smithhills Street and Incle Street), Forbes Place, Shuttle Street, Brown's Lane and Weighhouse Close and Forbes Place.

The Condition requires that services:

- (a) stop to set down and uplift passengers only at locations recognised and designated as bus stops or bus stands by the traffic authority;
- (b) take recovery time of no more than 5 minutes at bus stops which are designated as bus stands;
- (c) only use bus stops and bus stands, allocated to that particular service, which are determined by Renfrewshire Council;
- (d) between the hours of 7.30am and 6.30pm, may stop at bus stops only for the minimum period necessary for the safe setting down and uplifting of passengers. This restriction does not apply to marked bus stands.
