Special Notices

Concessionary fares

Concessionary fare schemes offer discounted travel on local public transport for older and disabled people. The Government wants to ensure that bus travel, in particular, remains within the means of those on limited incomes and those who have mobility difficulties. This supports our wider work to tackle social exclusion. Bus travel remains the most used form of public transport, especially by older people.

From 1 April 2006 older and disabled people will be entitled to at least free off peak local bus travel. If you are eligible for concessionary travel your local authority will provide you with further details about the scheme which operates in your area



Section 2

PSV Operator Licensing

Inspection of licence applications can be requested under the provisions of Regulation 4 of the Public Service Vehicles (Operators' Licences) Regulations 1995 by anybody who holds statutory Objector status. Applications may be inspected free of charge at the Traffic Commissioner's office by any person who carries written authorisation to act in that capacity. Alternatively, copies of weekly publications can be obtained by either an annual subscription of £91 or £3.50 for individual publications. Details can also be viewed by visiting **the VOSA website at www.vosa.gov.uk**

Objections against applications for licences may be made in writing by a Chief Officer of Police or local authority within 21 days after the date on which notice of an application is published in Notices and Proceedings. Objections must be made on the grounds that one or more of the requirements mentioned in Section 14(1) and (3) of the Public Passenger Vehicles Act 1981 are not satisfied in relation to the application. A copy of the objection must be sent by the Objector to the applicant at the same time that it is sent to the Traffic Commissioner. The onus of proof in terms of the grounds on which an objection is lodged lies with the objector. There is no right of objection against an application for a special licence submitted under Section 12 of the Transport Act 1985.

Classification of Operator Licences - There are four classes of licence: -

- A **Standard International (S/I)** licence authorises the use of any description of public service vehicle on both National and International operations;
- A **Standard National (S/N)** licence authorises the use of any description of public service vehicle on National operations;
- A **Restricted licence (R)** authorises the use of (a) public service vehicles not adapted to carry more than eight passengers and (b) those not adapted to carry more than sixteen passengers when used otherwise than in the course of a business of carrying passengers or by a person whose main occupation is not the operation of public service vehicles adapted to carry more than eight passengers;
- A **Special Restricted (SR)** licence under Section 12 of the Transport Act 1985 is granted to the holder of a taxi licence to enable local services to be operated.

Appeals in connection with PSV Operator Licences must be lodged with the Transport Tribunal, Procession House, 55 Ludgate Hill, London EC4M 7JW not later than 28 days after the date of the letter conveying the Traffic Commissioner's (or Deputy Traffic Commissioner's) decision. A copy of the appeals booklet is available from the Traffic Area Office on request. Registration Of Local Bus Services

The fee for each new application and variation application is £51. Applications to cancel registrations are free.

When an application is sent to the Traffic Area Office, a copy of all application forms and supporting documents must also be sent to each of the County Councils and Unitary Authorities in whose area the service will operate. Failure to do so may delay acceptance of that application.

Some of the periods of notice applicable before the operation of registered services, including variations or cancellations, are at the discretion of the Traffic Commissioner. In such cases the application must be accompanied by a written explanation of why a short notice period is required.

Any registration may be inspected at the office of the Traffic Commissioner during public business hours and copies of registrations can be sent by post or fax to any interested party upon prior receipt of a written request together with a fee of £3.00 per copy for posted copies or £5.00 per copy for faxed copies.
