IMPORTANT INFORMATION

Eastern Traffic Area - Change of Postal Address for Public Service Vehicle Operators.

Following a review by VOSA of its operations, the processing of Operator licence applications will be moving from the regional Traffic Area Offices to a central processing unit in Leeds.

This note contains important information about forthcoming changes to the Postal Address of the Eastern Traffic Area.

Centralisation will deliver more consistent handling of applications and an improved service with one correspondence address for all operator licensing.

The central processing unit will support the existing Traffic Commissioners and their role as the independent Licensing Authority will not be affected. Licences will continue to be issued by the Traffic Commissioners with the central unit processing applications for licences under each Traffic Commissioners' delegated authority.

Traffic Area boundaries will remain unchanged and Public Inquiries will continue to be held in the area of each Traffic Commissioner.

PSV Operator Licensing

Inspection of licence applications can be requested under the provisions of Regulation 4 of the Public Service Vehicles (Operators' Licences) Regulations 1995 by anybody who holds statutory Objector status. Applications may be inspected free of charge at the Traffic Commissioner's office by any person who carries written authorisation to act in that capacity. Alternatively, copies of weekly publications can be obtained by either an annual subscription of £91 or £3.50 for individual publications. Details can also be viewed by visiting **the VOSA website at www.transportoffice.gov.uk**

Objections against applications for licences may be made in writing by a Chief Officer of Police or local authority within 21 days after the date on which notice of an application is published in Notices and Proceedings. Objections must be made on the grounds that one or more of the requirements mentioned in Section 14(1) and (3) of the Public Passenger Vehicles Act 1981 are not satisfied in relation to the application. A copy of the objection must be sent by the Objector to the applicant at the same time that it is sent to the Traffic Commissioner. The onus of proof in terms of the grounds on which an objection is lodged lies with the objector. There is no right of objection against an application for a special licence submitted under Section 12 of the Transport Act 1985.

Classification of Operator Licences - There are four classes of licence: -

- A **Standard International (S/I)** licence authorises the use of any description of public service vehicle on both National and International operations;
- A **Standard National (S/N)** licence authorises the use of any description of public service vehicle on National operations;
- A **Restricted licence (R)** authorises the use of (a) public service vehicles not adapted to carry more than eight passengers and (b) those not adapted to carry more than sixteen passengers when used otherwise than in the course of a business of carrying passengers or by a person whose main occupation is not the operation of public service vehicles adapted to carry more than eight passengers;
- A **Special Restricted (SR)** licence under Section 12 of the Transport Act 1985 is granted to the holder of a taxi licence to enable local services to be operated.

Appeals in connection with PSV Operator Licences must be lodged with the Transport Tribunal, Procession House, 55 Ludgate Hill, London EC4M 7JW not later than 28 days after the date of the letter conveying the Traffic Commissioner's (or Deputy Traffic Commissioner's) decision. A copy of the appeals booklet is available from the Traffic Area Office on request. Further to the notice which was published in Notice & Proceedings 2018 the Traffic Commissioner has determined the following Traffic Regulation Condition in Castle Meadow, Norwich :

Traffic Regulation Condition to be attached to the PSV operator licences of all operators currently operating or wishing to operate local bus services registered under the Transport Act 1985 where the registered route of the service includes Castle Meadow, Norwich, except for services meeting one of the following criteria.

1. Local bus services with less than five departures per week from Castle Meadow
2. Local bus services operated under contract to Norfolk County Council where the existing contract expires on or before 30 September 2008

As from 1 April 2008, 40 per cent of the vehicles used on local bus services operating in Castle Meadow, Norwich and with both registered terminal points within the area defined in Figure 1 (see attached plan, drawing number TSB1410/TD/015) will be

required to comply with the Euro III (or equivalent) or higher exhaust emission standard.

As from 1 April 2008, 20 per cent of the vehicles used on local bus services operating in Castle Meadow, Norwich and with a registered terminal point outside the area defined in Figure 1 will be required to comply with the Euro III (or equivalent) or higher exhaust emission standard.

As from 1 April 2009, 70 per cent of the vehicles used on local bus services operating in Castle Meadow, Norwich and with both registered terminal points within the area defined in Figure 1 will be required to comply with the Euro III (or equivalent) or higher exhaust emission standard.

As from 1 April 2009, 35 per cent of the vehicles used on local bus services operating in Castle Meadow, Norwich and with a registered terminal point outside the area defined in Figure 1 will be required to comply with the Euro III (or equivalent) or higher exhaust emission standard.

As from 1 April 2010, all vehicles used on local bus services operating in Castle Meadow, Norwich and with both registered terminal points within the area defined in Figure 1 will be required to comply with the Euro III (or equivalent) or higher exhaust emission standard.

As from 1 April 2010, 50 per cent of the vehicles used on local bus services operating in Castle Meadow, Norwich and with a registered terminal point outside the area defined in Figure 1 will be required to comply with the Euro III (or equivalent) or higher exhaust emission standard.

In order to monitor compliance with this Condition, as from 1 April 2008 PSV operators must supply details of the emissions capability as defined by the equivalent Euro exhaust emissions standards of each vehicle within their bus fleet used on local bus services operating in Castle Meadow to the Director of Planning and Transportation, Norfolk County Council. Updated information is to be supplied to the Council at six monthly intervals for receipt by 31 March and 30 September each year.

Section 5.1 Notice Of Public Inquiries To Be Held
