#### PSV Operator Licensing

**Inspection of licence applications** can be requested under the provisions of Regulation 4 of the Public Service Vehicles (Operators' Licences) Regulations 1995 by anybody who holds statutory Objector status. Applications may be inspected free of charge at the Traffic Commissioner's office by any person who carries written authorisation to act in that capacity. Alternatively, copies of weekly publications can be obtained by either an annual subscription of £91 or £3.50 for individual publications. Details can also be viewed by visiting the **VOSA website** at [www.vosa.gov.uk](http://www.vosa.gov.uk)

**Objections against applications for licences** may be made in writing by a Chief Officer of Police or local authority within 21 days after the date on which notice of an application is published in Notices and Proceedings. Objections must be made on the grounds that one or more of the requirements mentioned in Section 14(1) and (3) of the Public Passenger Vehicles Act 1981 are not satisfied in relation to the application. A copy of the objection must be sent by the Objector to the applicant at the same time that it is sent to the Traffic Commissioner. The onus of proof in terms of the grounds on which an objection is lodged lies with the objector. There is no right of objection against an application for a special licence submitted under Section 12 of the Transport Act 1985.

**Classification of Operator Licences** - There are four classes of licence: -

- A **Standard International (S/I)** licence authorises the use of any description of public service vehicle on both National and International operations;
- A **Standard National (S/N)** licence authorises the use of any description of public service vehicle on National operations;
- A **Restricted licence (R)** authorises the use of (a) public service vehicles not adapted to carry more than eight passengers and (b) those not adapted to carry more than sixteen passengers when used otherwise than in the course of a business of carrying passengers or by a person whose main occupation is not the operation of public service vehicles adapted to carry more than eight passengers;
- A **Special Restricted (SR)** licence under Section 12 of the Transport Act 1985 is granted to the holder of a taxi licence to enable local services to be operated.

**Appeals in connection with PSV Operator Licences** must be lodged with the Transport Tribunal, 48-49 Chancery Lane, London WC2A 1JR not later than 28 days after the date of the letter conveying the Traffic Commissioner's (or Deputy Traffic Commissioner's) decision. A copy of the appeals booklet is available from the Traffic Area Office on request. #### **SPECIAL NOTICE TO HOLDERS OF LONDON LOCAL SERVICE LICENCES EXPIRING IN 2005**

A large number of London Local Service Licences are due to expire in 2005 compared to a smaller number that expire in 2004. To more evenly balance the number of replacement applications required for London Service Permits over the two year period, holders of existing London Local Service Licences that are not due to expire until 2005, are advised that during the period 1 March 2004 to 30 April 2004, TfL London Buses will be accepting early applications for London Service Permits. The normal £150 fee will be waived – only applicable

to replacements of London Local Service Licences expiring in 2005 – during the period 1 March to 30 April 2004.

The applications will be subject to TfL’s current procedure on the London Service Permit process. Providing they meet the Mayor’s criteria and there are no valid objections raised by statutory authorities or by Transport for London, the applications will be granted during 2004 for a maximum period of up to 5 years on condition that the operator surrenders their respective London Local Service Licence(s) to the Traffic Commissioner.
