"WEYMOUTH CARNIVAL - WEDNESDAY 20 AUGUST 2003

Coach passengers on a day trip to Weymouth invariably disembark at coach stops on the seaward side of the Esplanade near the Tourist Information Centre or opposite the Fairhaven Hotel during the morning and are collected from there during the late afternoon. On Carnival Day the Esplanade will be closed to all traffic at 4.45pm and will not be open again until approximately 8.00pm. Coach drivers bringing parties to Weymouth on Carnival Day are advised therefore to collect passengers from the Esplanade no later than 4.30pm. If any further information is required, please contact the Department of Environmental Services, Council Offices, North Quay, Weymouth DT4 8TA [tel. 01305 838291]."

"THE ESPLANADE, WEYMOUTH - COACH SETTING DOWN AND PICKING UP POINTS

Coach operators are reminded that the seaward side of the Esplanade is subject to a waiting/loading ban from Brunswick Terrace as far as the Royal Hotel, to the south of King Street. The stopping of coaches on this length of road is therefore illegal and can cause severe congestion at times, especially when this takes place in the bus lane. A coach stopping area is available at bus stop K7 near the Tourist Information Centre and in addition to this stopping is permitted for set down/pick up purposes opposite the Fairhaven Hotel or on the forecourt of the Pavilion. Coach parking facilities remain available adjacent to Jubilee Business Park, which may be accessed from Kings Roundabout, and Lodmoor car park. Section 2

PSV Operator Licensing

Inspection of licence applications can be requested under the provisions of Regulation 4 of the Public Service Vehicles (Operators' Licences) Regulations 1995 by anybody who holds statutory Objector status. Applications may be inspected free of charge at the Traffic Commissioner's office by any person who carries written authorisation to act in that capacity. Alternatively, copies of weekly publications can be obtained by either an annual subscription of £91 or £3.50 for individual publications. Details can also be viewed by visiting **the VOSA website at www.vosa.gov.uk**

Objections against applications for licences may be made in writing by a Chief Officer of Police or local authority within 21 days after the date on which notice of an application is published in Notices and Proceedings. Objections must be made on the grounds that one or more of the requirements mentioned in Section 14(1) and (3) of the Public Passenger Vehicles Act 1981 are not satisfied in relation to the application. A copy of the objection must be sent by the Objector to the applicant at the same time that it is sent to the Traffic Commissioner. The onus of proof in terms of the grounds on

which an objection is lodged lies with the objector. There is no right of objection against an application for a special licence submitted under Section 12 of the Transport Act 1985.

Classification of Operator Licences - There are four classes of licence: -

- A **Standard International (S/I)** licence authorises the use of any description of public service vehicle on both National and International operations;
- A **Standard National (S/N)** licence authorises the use of any description of public service vehicle on National operations;
- A **Restricted licence (R)** authorises the use of (a) public service vehicles not adapted to carry more than eight passengers and (b) those not adapted to carry more than sixteen passengers when used otherwise than in the course of a business of carrying passengers or by a person whose main occupation is not the operation of public service vehicles adapted to carry more than eight passengers;
- A **Special Restricted (SR)** licence under Section 12 of the Transport Act 1985 is granted to the holder of a taxi licence to enable local services to be operated.

Appeals in connection with PSV Operator Licences must be lodged with the Transport Tribunal, 48-49 Chancery Lane, London WC2A 1JR not later than 28 days after the date of the letter conveying the Traffic Commissioner's (or Deputy Traffic Commissioner's) decision. A copy of the appeals booklet is available from the Traffic Area Office on request. Some of the periods of notice applicable before the operation of registered services, including variations or cancellations, are at the discretion of the Traffic Commissioner. In such cases the application must be accompanied by a written explanation of why a short notice period is required.
