Section 2

PSV Operator Licensing

Inspection of licence applications can be requested under the provisions of Regulation 4 of the Public Service Vehicles (Operators' Licences) Regulations 1995 by anybody who holds statutory Objector status. Applications may be inspected free of charge at the Traffic Commissioner's office by any person who carries written authorisation to act in that capacity. Alternatively, copies of weekly publications can be obtained by either an annual subscription of £91 or £3.50 for individual publications. Details can also be viewed by visiting **the VOSA website at www.vosa.gov.uk**

Objections against applications for licences may be made in writing by a Chief Officer of Police or local authority within 21 days after the date on which notice of an application is published in Notices and Proceedings. Objections must be made on the grounds that one or more of the requirements mentioned in Section 14(1) and (3) of the Public Passenger Vehicles Act 1981 are not satisfied in relation to the application. A copy of the objection must be sent by the Objector to the applicant at the same time that it is sent to the Traffic Commissioner. The onus of proof in terms of the grounds on which an objection is lodged lies with the objector. There is no right of objection against an application for a special licence submitted under Section 12 of the Transport Act 1985.

Classification of Operator Licences - There are four classes of licence: -

- A **Standard International (S/I)** licence authorises the use of any description of public service vehicle on both National and International operations;
- A **Standard National (S/N)** licence authorises the use of any description of public service vehicle on National operations;
- A **Restricted licence (R)** authorises the use of (a) public service vehicles not adapted to carry more than eight passengers and (b) those not adapted to carry more than sixteen passengers when used otherwise than in the course of a business of carrying passengers or by a person whose main occupation is not the operation of public service vehicles adapted to carry more than eight passengers;
- A **Special Restricted (SR)** licence under Section 12 of the Transport Act 1985 is granted to the holder of a taxi licence to enable local services to be operated.

Appeals in connection with PSV Operator Licences must be lodged with the Transport Tribunal, Procession House, 55 Ludgate Hill, London EC4M 7JW not later than 28 days after the date of the letter conveying the Traffic Commissioner's (or Deputy Traffic Commissioner's) decision. A copy of the appeals booklet is available from the Traffic Area Office on request. Appellants can alternatively obtain guidance on lodging appeals by visiting **the VOSA website at www.vosa.gov.uk**

Registration Of Local Bus Services

The fee for each new application and variation application is £45. Applications to cancel registrations are free.

When an application is sent to the Traffic Area Office, a copy of all application forms and supporting documents must also be sent to each of the County Councils and Unitary Authorities in whose area the service will operate. Failure to do so may delay acceptance of that application.

Some of the periods of notice applicable before the operation of registered services, including variations or cancellations, are at the discretion of the Traffic Commissioner. In such cases the application must be accompanied by a written explanation of why a short notice period is required.

Any registration may be inspected at the office of the Traffic Commissioner during public business hours and copies of registrations can be sent by post or fax to any interested party upon prior receipt of a written request together with a fee of £3.00 per copy for posted copies or £5.00 per copy for faxed copies.

Local Bus Service Registration - requests for early start/stop dates

When considering "short notice" applications where an early start/stop/change date (i.e. less than the normal 56 days notice period) is requested, we require PSV 350A to accompany PSV 350 and any relevant supporting information that will assist consideration of the justification for an early date.

Applications can relate to:

- (a) tendered services submitted at the request of the local authority (e.g. for schools services);
- (b) commercial services.

You will appreciate that not every application is submitted personally to the Traffic Commissioner, and (as in local government) some decisions are delegated to the Team Leaders - who in particular may determine short notice applications where the service is a tendered service, provided good reasons are given and the local authority supports the application and gives an assurance that there will be no competitive implications.

We have tended to work on the basis that a tender/contract is not normally awarded if there is a commercial service already in place, and therefore we have taken the view (rightly or wrongly) that there are no competitive implications. For the future we need to get such an assurance from the local authority.

The Traffic Commissioner is requesting the introduction of arrangements where in the case of an application that is subsidised or partly subsidised the application must be accompanied by a detailed support letter from the local authority which will include an assurance that there are no competitive implications. For commercial services, unless there are particular circumstances that allow a local authority to lend support to a short notice application, we don't normally receive support correspondence from them.

These arrangements will come into force from 1 April 2005 and any application received after this date that requires Local Authority support will not be input. The Operator will receive a request to supply a letter of support from the Local Authority which may delay the proposed start/amendment date of the service. These new arrangements will hopefully speed up the time taken to confirm acceptance by the Traffic Commissioners Office of your application.
