IMPORTANT INFORMATION

Western Traffic Area - Change of Postal Address from 7 August 2006 for Goods Vehicle Operators and Public Service Vehicle Operators.

Following a review by VOSA of its operations, the processing of Operator licence applications will be moving from the regional Traffic Area Offices to a central processing unit in Leeds.

This note contains important information about forthcoming changes to the Postal Address of the Western Traffic Area. The changes for the Western Traffic Area will take place from 7 August 2006.

Centralisation will deliver more consistent handling of applications and an improved service with one correspondence address for all operator licensing.

The central processing unit will support the existing Traffic Commissioners and their role as the independent Licensing Authority will not be affected. Licences will continue to be issued by the Traffic Commissioners with the central unit processing applications for licences under each Traffic Commissioners' delegated authority.

Traffic Area boundaries will remain unchanged and Public Inquiries will continue to be held in the area of each Traffic Commissioner.

Section 2

PSV Operator Licensing

Inspection of licence applications can be requested under the provisions of Regulation 4 of the Public Service Vehicles (Operators’ Licences) Regulations 1995 by anybody who holds statutory Objector status. Applications may be inspected free of charge at the Traffic Commissioner’s office by any person who carries written authorisation to act in that capacity. Alternatively, copies of weekly publications can be obtained by either an annual subscription of £91 or £3.50 for individual publications. Details can also be viewed by visiting **the VOSA website at www.transportoffice.gov.uk**

Objections against applications for licences may be made in writing by a Chief Officer of Police or local authority within 21 days after the date on which notice of an application is published in Notices and Proceedings. Objections must be made on the grounds that one or more of the requirements mentioned in Section 14(1) and (3) of the Public Passenger Vehicles Act 1981 are not satisfied in relation to the application. A copy of the objection must be sent by the Objector to the applicant at the same time that it is sent to the Traffic Commissioner. The onus of proof in terms of the grounds on which an objection is lodged lies with the objector. There is no right of objection against an application for a special licence submitted under Section 12 of the Transport Act 1985.

Classification of Operator Licences - There are four classes of licence: -

- A **Standard International (S/I)** licence authorises the use of any description of public service vehicle on both National and International operations;
- A **Standard National (S/N)** licence authorises the use of any description of public service vehicle on National operations;
- A **Restricted licence (R)** authorises the use of (a) public service vehicles not adapted to carry more than eight passengers and (b) those not adapted to carry more than sixteen passengers when used otherwise than in the course of a business of carrying passengers or by a person whose main occupation is not the operation of public service vehicles adapted to carry more than eight passengers;
- A **Special Restricted (SR)** licence under Section 12 of the Transport Act 1985 is granted to the holder of a taxi licence to enable local services to be operated.

Appeals in connection with PSV Operator Licences must be lodged with the Transport Tribunal, Procession House, 55 Ludgate Hill, London EC4M 7JW not later than 28 days after the date of the letter conveying the Traffic Commissioner's (or Deputy Traffic Commissioner's) decision. A copy of the appeals booklet is available from the Traffic Area Office on request. Appellants can alternatively obtain guidance on lodging appeals by visiting **the VOSA website at www.transportoffice.gov.uk**

Registration Of Local Bus Services

The fee for each new application and variation application is £54. Applications to cancel registrations are free.

When an application is sent to the Traffic Area Office, a copy of all application forms and supporting documents must also be sent to each of the County Councils and Unitary Authorities in whose area the service will operate. Failure to do so may delay acceptance of that application.

Some of the periods of notice applicable before the operation of registered services, including variations or cancellations, are at the discretion of the Traffic Commissioner. In such cases the application must be accompanied by a written explanation of why a short notice period is required.

Any registration may be inspected at the office of the Traffic Commissioner during public business hours and copies of registrations can be sent by post or fax to any interested party upon prior receipt of a written request together with a fee of £3.00 per copy for posted copies or £5.00 per copy for faxed copies.

1) The Operator is to apply within 7 days of today's hearing for the issue of a further 4 vehicles discs. Unless and until those discs are issued and in the possession of the Operator it shall cease any use of vehicles displaying Premier Travel Ltd discs from 11:59 hours today at the latest and shall not operate any vehicles without displaying a disc issued in this Operator's name.

2) The following undertakings given at the Public Inquiry shall be attached to this Licence with immediate effect.

a) There will be a nil defect daily driver reporting system. Defect reports will show rectification and all reports will be retained for at least 2 years. Drivers will also walkround and record complete reports after each and every school journey undertaken, concentrating on seat belt condition.

b) The Operator will undertake a random audit of at least 2 drivers per day to ensure the drivers are undertaking their walk round checks correctly. The findings will be recorded and made available to staff from VOSA or the Office of the Traffic Commissioner on request.

c) All authorised vehicles will have a rolling road brake test every PMI not including the MOT. The results will be recorded and records kept for at least 2 years.

d) Maintenance systems, maintenance documentation and vehicle inspections will be audited by SPC Transport Consultancy every month. Audit reports will be prepared, acted upon and retained for at least 2 years. A copy of the report will be forwarded to the Western Traffic Area Office within 14 days of its receipt together with the Operator's proposals for implementing its recommendations.

e) All authorised vehicles will have a thorough and effective pre-MOT inspection. Records to be kept for at least 2 years.

f) All tachographs will be independently analysed and monthly reports will be prepared, acted upon and retained for at least 2 years.

g) A training programme for drivers provided by SPC Transport Consultancy and relating to driver walkrounds will be implemented, and fully completed by end August 2008. Written details of sessions and attendees must be submitted to the Western Traffic Area Office within 10 days of the course. Thereafter, the operator will ensure that all existing and new drivers will receive annual training and records of all training sessions and attendees will be kept for at least 2 years.

h) The Transport Manager shall resign and a replacement qualified Transport Manager shall be appointed within 14 days of today's hearing.

N.B. It should be noted that in the event of the Operator being unable to comply with any of the undertakings given above, for reasons beyond his/its control, the Operator should contact the Office of the Traffic Commissioner WITHOUT DELAY to explain the situation.

3) The repute of the Transport Manager has been significantly damaged by the shortcomings found by me at this Inquiry. His professional competence has been called into serious question. I accept that he is resigning as Transport Manager pursuant to the foregoing undertakings and following this action find that his repute has not been lost.

4) The Operator's Licence is varied such that the condition specifying the maximum number of vehicles which the Operator may at any one time use under the licence is varied such that the maximum number of vehicles specified in the Operator's licence be reduced to 6 vehicles for a consecutive period of 14 days to be implemented and completed by no later than 31st August 2008. The operator shall advise the Western Traffic Area Office of the Traffic Commissioner of the 14 consecutive day period of curtailment that shall be observed by it.

5) The Operator shall supply Western Traffic Area Office of the Traffic Commissioner within 14 days with a list of: all local bus services currently being operated by the business of Eastville Coaches Limited to schools or otherwise.

6) VOSA are requested to undertake a further Maintenance Investigation in 6 months.

7) For the avoidance of doubt this decision does not address any licence compliance issues indicated by the evidence at Public Inquiry regarding the Operator Premier Travel Limited.
