PSV Operator Licensing

Inspection of licence applications can be requested under the provisions of Regulation 4 of the Public Service Vehicles (Operators' Licences) Regulations 1995 by anybody who holds statutory Objector status. Applications may be inspected free of charge at the Traffic Commissioner's office by any person who carries written authorisation to act in that capacity. Alternatively, copies of weekly publications can be obtained by either an annual subscription of £91 or £3.50 for individual publications. Details can also be viewed by visiting **the VOSA website at www.vosa.gov.uk**

Objections against applications for licences may be made in writing by a Chief Officer of Police or local authority within 21 days after the date on which notice of an application is published in Notices and Proceedings. Objections must be made on the grounds that one or more of the requirements mentioned in Section 14(1) and (3) of the Public Passenger Vehicles Act 1981 are not satisfied in relation to the application. A copy of the objection must be sent by the Objector to the applicant at the same time that it is sent to the Traffic Commissioner. The onus of proof in terms of the grounds on which an objection is lodged lies with the objector. There is no right of objection against an application for a special licence submitted under Section 12 of the Transport Act 1985.

Classification of Operator Licences - There are four classes of licence: -

- A **Standard International (S/I)** licence authorises the use of any description of public service vehicle on both National and International operations;
- A **Standard National (S/N)** licence authorises the use of any description of public service vehicle on National operations;
- A **Restricted licence (R)** authorises the use of (a) public service vehicles not adapted to carry more than eight passengers and (b) those not adapted to carry more than sixteen passengers when used otherwise than in the course of a business of carrying passengers or by a person whose main occupation is not the operation of public service vehicles adapted to carry more than eight passengers;
- A **Special Restricted (SR)** licence under Section 12 of the Transport Act 1985 is granted to the holder of a taxi licence to enable local services to be operated.

Appeals in connection with PSV Operator Licences must be lodged with the Transport Tribunal, Procession House, 55 Ludgate Hill, London EC4M 7JW not later than 28 days after the date of the letter conveying the Traffic Commissioner's (or Deputy Traffic Commissioner's) decision. A copy of the appeals booklet is available from the Traffic Area Office on request. Appellants can alternatively obtain guidance on lodging appeals by visiting **the VOSA website at www.vosa.gov.uk**

Registration Of Local Bus Services

The fee for each new application and variation application is £51. Applications to cancel registrations are free.

When an application is sent to the Traffic Area Office, a copy of all application forms and supporting documents must also be sent to each of the County Councils and Unitary Authorities in whose area the service will operate. Failure to do so may delay acceptance of that application.

Some of the periods of notice applicable before the operation of registered services, including variations or cancellations, are at the discretion of the Traffic Commissioner. In such cases the application must be accompanied by a written explanation of why a short notice period is required.

Any registration may be inspected at the office of the Traffic Commissioner during public business hours and copies of registrations can be sent by post or fax to any interested party upon prior receipt of a written request together with a fee of £3.00 per copy for posted copies or £5.00 per copy for faxed copies.

TRAFFIC REGULATION CONDITIONS

Section 4.1 Requests

Section 4.2 Determinations

The Traffic Commissioner has been requested by Manchester City Council, PO Box 532, Town Hall, Manchester M60 2LA to determine a Traffic Regulation Condition under Section 7 of the Transport Act 1985. The Council have requested that the Traffic Commissioner uses her powers under Section 7(10) of the 1985 Transport Act to determine the condition without delay.

In view of the danger to road users and severe traffic Congestion the Traffic Commissioner has decided it is appropriate to impose a Traffic Regulation Condition without delay under Section 7(10) of the 1985 Transport Act and the Traffic Regulation Condition will be effective from 06.00 on 8 September 2006

The condition Determined is as follows: -

The Traffic Commissioner has imposed a Traffic Regulation Condition designed to govern the operation of local bus services on those bus stands shown on the plan below. It will cap the use of bus stands to safe limits and set a maximum hourly frequency of buses permitted to access Parker Street.

The aim of the Condition is to address existing and potential future problems of severe congestion and road safety arising from the operation of local bus services from these stands, whilst maximizing the utility and capacity of the Parker Street bus stands J, K, L, M, G, H, N, and P.



1. Stand Capacity (maximum number of registrations)

A maximum limit will be imposed on the number of departures that can be registered from each stand. These will be as set out in the table below.

| Stand Identity | Stand Length | Stand Designation | Stand Capacity | Departure Gap |
|----------------|--------------|-------------------|-------------------|--------------------|
| G | 36 metres | Triple | 24 buses per hour | At least 2 minutes |
| H | 36 metres | Triple | 24 buses per hour | At least 2 minutes |
| J | 24 metres | Double | 18 buses per hour | At least 3 minutes |
| K | 24 metres | Double | 18 buses per hour | At least 3 minutes |
| L | 24 metres | Double | 18 buses per hour | At least 3 minutes |
| M | 24 metres | Double | 18 buses per hour | At least 3 minutes |
| N | 36 metres | Triple | 24 buses per hour | At least 2 minutes |
| P | 36 metres | Triple | 24 buses per hour | At least 2 minutes |

Operators wishing to use these stands must stipulate which stand they intend to use when they register or vary their services. They must also stipulate arrival and departure times (ensuring that the interval does not exceed 5 minutes) for each service and in addition:

- At double stands, the service arrival must be registered to arrive at least 3 minutes after the previous service
- At triple stands, the service arrival must be registered to arrive at least 2 minutes after the previous service

2. Waiting Time

No registration will be accepted which indicates that a bus will be scheduled to wait at stands G,H,J,K,L,M,N and P for more than a five minute period.

This five minute period will begin as soon as the bus driver draws onto the bus stand. Drivers should move forward in accordance with departure times, thus providing each bus two minutes (on triple stands) and three minutes (on the double stands) at the front boarding point at that stand. In practice, no bus will be permitted to wait longer than 5 minutes at any stand.

3. Maximum bus service frequency along Parker Street

THE TOTAL NUMBER OF BUSES IN SERVICE PERMITTED TO ACCESS PARKER STREET SHALL NOT EXCEED 168 PER HOUR. NO "OUT OF SERVICE" BUSES SHALL ACCESS PARKER STREET.

4. Frequent Services

Operators must provide the Traffic Commissioner and the GMPTE with a specific working timetable of all bus services including those registered as 'frequent services' which are scheduled to operate from stands G,H,J,K,L,M,N and P.

5. Alighting and Boarding Conditions

No bus shall stop to board or alight passengers from the offside of any other bus, nor obstruct other traffic on the carriageway should their intended stand be occupied.

When pulling up to the stands, drivers must ensure that their vehicle is fully within the marked bay (and hence not obstructing the carriageway).

6. Classification of bus stands

A double bus stand is defined as follows:

- There is a gap of at least three minutes between the requested departure and the preceding journey.
- There is a gap of at least three minutes between the requested departure and the following journey.
- That the total number of departures from the stand will not exceed 18 in that particular hour.
- The maximum number of buses permitted on this stand at any time is two.

A triple bus stand is defined as follows:

- There is a gap of at least two minutes between the requested departure and the preceding journey.
- There is a gap of at least two minutes between the requested departure and the following journey.

- That the total number of departures from the stand will not exceed 24 in that particular hour.
- The maximum number of buses permitted on this stand at any time is three.

A transcript of the taped proceedings of Public Inquiries (either in full or in part) may be ordered from the Traffic Area Office Compliance Unit. The cost of the transcript varies according to demand and size of content and the Compliance Unit will be able to advise on the scale of charges when an order is placed.

Appeals in connection with PSV Operator Licences must be lodged with the Transport Tribunal, Procession House, 55 Ludgate Hill, London EC4M 7JW not later than 28 days after the date of the letter conveying the Traffic Commissioner's (or Deputy Traffic Commissioner's) decision. A copy of the appeals booklet is available from the Traffic Area Office on request.
