### Section 2

#### PSV Operator Licensing

**Inspection of licence applications** can be requested under the provisions of Regulation 4 of the Public Service Vehicles (Operators' Licences) Regulations 1995 by anybody who holds statutory Objector status. Applications may be inspected free of charge at the Traffic Commissioner's office by any person who carries written authorisation to act in that capacity. Alternatively, copies of weekly publications can be obtained by either an annual subscription of £91 or £3.50 for individual publications. Details can also be viewed by visiting **the VOSA website at [www.transportoffice.gov.uk](http://www.transportoffice.gov.uk)**

**Objections against applications for licences** may be made in writing by a Chief Officer of Police or local authority within 21 days after the date on which notice of an application is published in Notices and Proceedings. Objections must be made on the grounds that one or more of the requirements mentioned in Section 14(1) and (3) of the Public Passenger Vehicles Act 1981 are not satisfied in relation to the application. A copy of the objection must be sent by the Objector to the applicant at the same time that it is sent to the Traffic Commissioner. The onus of proof in terms of the grounds on which an objection is lodged lies with the objector. There is no right of objection against an application for a special licence submitted under Section 12 of the Transport Act 1985.

**Classification of Operator Licences** - There are four classes of licence: -

- A **Standard International (S/I)** licence authorises the use of any description of public service vehicle on both National and International operations;
- A **Standard National (S/N)** licence authorises the use of any description of public service vehicle on National operations;
- A **Restricted licence (R)** authorises the use of (a) public service vehicles not adapted to carry more than eight passengers and (b) those not adapted to carry more than sixteen passengers when used otherwise than in the course of a business of carrying passengers or by a person whose main occupation is not the operation of public service vehicles adapted to carry more than eight passengers;
- A **Special Restricted (SR)** licence under Section 12 of the Transport Act 1985 is granted to the holder of a taxi licence to enable local services to be operated.

**Appeals in connection with PSV Operator Licences** must be lodged with the Transport Tribunal, Procession House, 55 Ludgate Hill, London EC4M 7JW not later than 28 days after the date of the letter conveying the Traffic Commissioner's (or Deputy Traffic Commissioner's) decision. A copy of the appeals booklet is available from the Traffic Area Office on request. ## Registration Of Local Bus Services

The fee for each new application and variation application is £54. Applications to cancel registrations are free.

When an application is sent to the Traffic Area Office, a copy of all application forms and supporting documents must also be sent to each of the County Councils and Unitary Authorities in whose area the service will operate. Failure to do so may delay acceptance of that application.

Some of the periods of notice applicable before the operation of registered services, including variations or cancellations, are at the discretion of the Traffic Commissioner. In such cases the application must be accompanied by a written explanation of why a short notice period is required.

## **BUS STOPS AND BUS STANDS IN THE ENVIRONS OF THE OWENS PARK HALLS OF RESIDENCE, WILMSLOW RD, FALLOWFIELD**

### **INTRODUCTION**

The Traffic Commissioner is requested to amend the existing Traffic Regulation Condition (TRC, Number 18, April 1995) to control the operation of bus services utilising four new bus stops and three new bus stands identified on the plans below.

The aim of the amendment to the TRC is to address existing and future road safety and severe congestion problems and arising from the inappropriate operation of bus services from these stops and stands, whilst maximizing the utility and capacity of them and the bus lanes.

### **OPERATION**

All elements of the amended TRC are expected to operate on a 24 hour / 7 day basis.

### **DEFINITIONS**

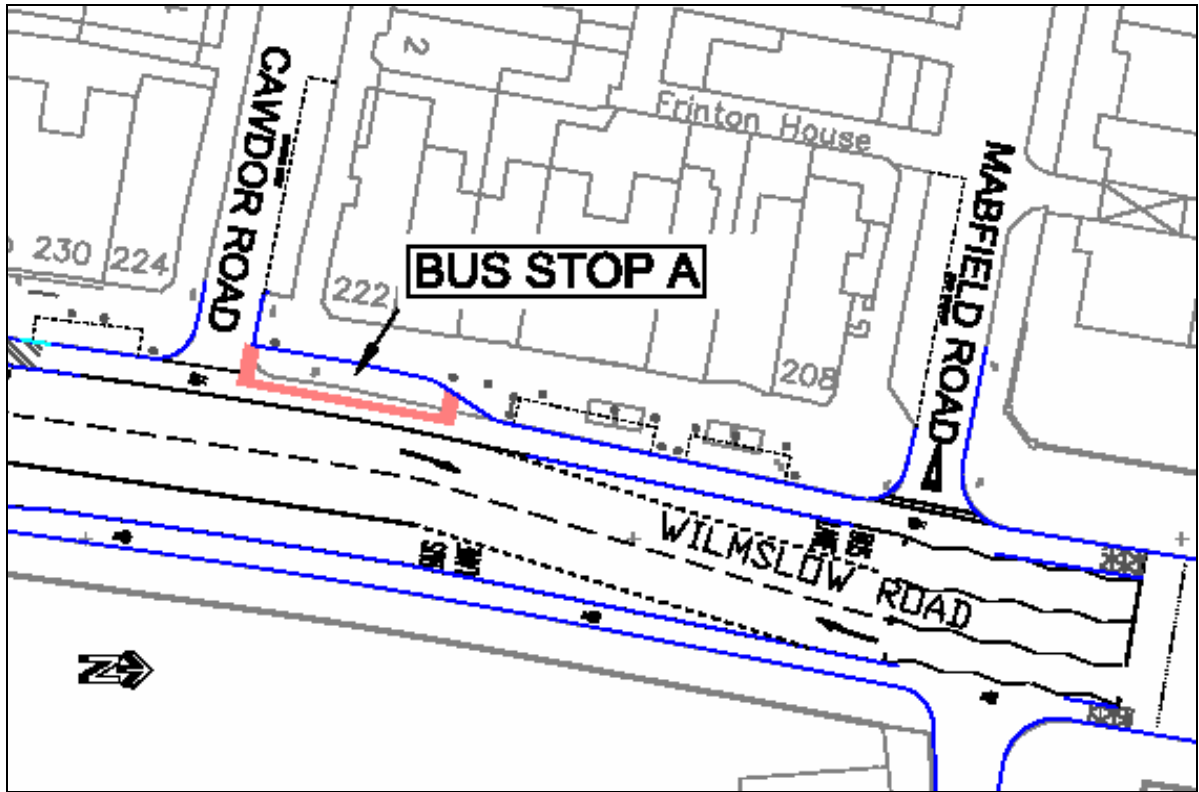

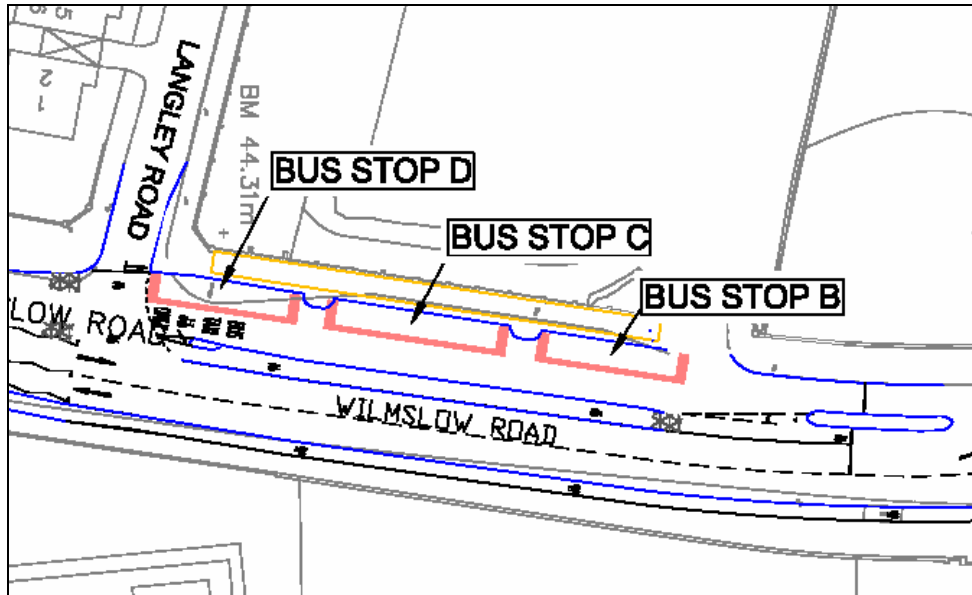


- 1.1 No bus is permitted to stop or wait at Bus Stop "A" except for as long as is necessary to allow passengers to alight from the bus.

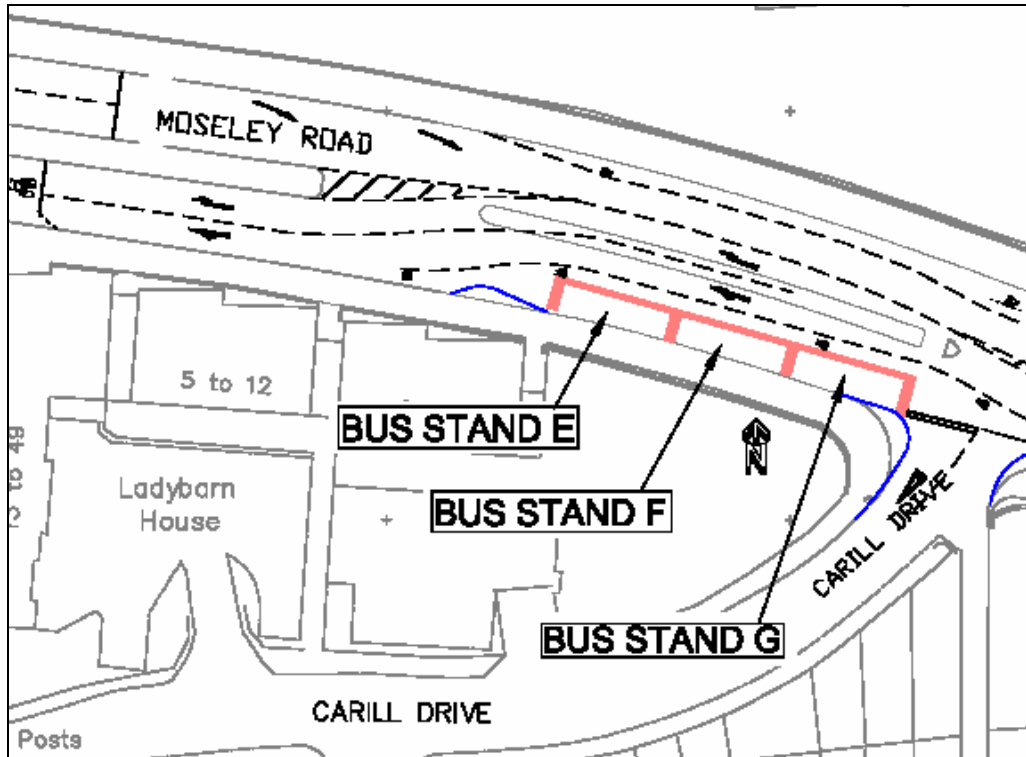


- 2.1 The maximum number of buses permitted to wait at any one time at is:-

- 2.4.1 No bus shall stop or wait at Bus Stops "B", "C" or "D" otherwise than wholly within the limits of the bay marked for that bus stop.

- 3.1 The maximum number of buses permitted to wait at any one time at:-
- Bus Stand "E" is one  
 Bus Stand "F" is one  
 Bus Stand "G" is one
- 3.2 No bus shall stop or wait at Bus Stands "E", "F" or "G" otherwise than wholly within the limits of the bay marked for that bus stand.
- 3.3 No boarding or alighting of passengers may be carried out by any bus whilst it is stopped or waiting at Bus Stands "E", "F" or "G".
- 3.4 No bus may stop or wait at Bus Stands "E", "F" or "G" unless it is waiting to move onto the Langley Road Bus Stops (shown on Plan 2).
- 3.5 No bus is permitted to wait at Bus Stands "E", "F" or "G" for a period in excess of 15 minutes.
- 3.6 No bus at Bus Stands "E", "F" or "G" may wait for longer than 5 minutes with its engine running. After this time the bus engine shall be switched off.

Any affected operator may request the Traffic Commissioner to hold a Public Inquiry regarding this matter. Any request for such an inquiry should be made within 28 days of the date of this publication
