Section 2 – PSV Operator Licensing

Inspection of licence applications can be requested under the provisions of Regulation 4 of the Public Service Vehicles (Operators' Licences) Regulations 1995 by anybody who holds statutory objector status. Applications may be inspected free of charge at the traffic area office in Leeds by any person who carries written authorisation to act in that capacity.

Objections against applications for licences must be made in writing by a Chief Officer of Police or by a local authority within 21 days of the date on which notice of an application is published in Notices and Proceedings. Objections must be made on the grounds that one or more of the requirements mentioned in Sections 14(1) and (3) of the Public Passenger Vehicles Act 1981 are not satisfied in relation to the application. A copy of the objection must be sent by the objector to the applicant at the same time that it is sent to the Traffic Commissioner. The onus of proof in terms of the grounds on which an objection is lodged lies with the objector. There is no right of objection against an application for a special licence submitted under Section 12 of the Transport Act 1985.

Classification of Operator Licences – There are four classes of licence:

- A **Standard International (SI)** licence authorises the use of any description of public service vehicle on both national and international operations;
- A **Standard National (SN)** licence authorises the use of any description of public service vehicle on national operations;
- A **Restricted licence (R)** authorises the use of:
 - a) public service vehicles not adapted to carry more than eight passengers; and
 - b) those not adapted to carry more than sixteen passengers when used otherwise than in the course of a business of carrying passengers or by a person whose main occupation is not the operation of public service vehicles adapted to carry more than eight passengers;
- A **Special Restricted (SR)** licence, issued under Section 12 of the Transport Act 1985, authorises the holder of a taxi or private hire vehicle licence to operate local services.

Appeals in connection with PSV Operator Licences must be lodged with the Upper Tribunal – Administrative Appeal Chamber (Transport), 7th Floor, Victory House, 30-34 Kingsway, London, WC2B 6EX not later than 28 days after the date of the letter conveying the Traffic Commissioner's (or Deputy Traffic Commissioner's) decision. New Condition: The service must have been advertised to the public, so as to create a genuine opportunity for members of the public to be carried on the particular journey in question. i.e. the journey is not an exclusive hiring for an individual or group. Advertisement at a place of worship, a place of work, a club or other voluntary association for the information of people present at those places, or in periodicals circulated wholly or mainly or mainly among such persons, does not count as advertisement to the general public. Attached to Licence.

New Condition: The service was not advertised as per condition 1, but the arrangements for (i) bringing together the passengers, and (ii) the payment of separate fares, were initiated by the driver, operator or owner of the vehicle, or some other intermediary who is paid for doing so – not by the passengers themselves, or any other party. This condition might be met where the transport provider has identified a number of people each wanting to make the same journey, and has suggested to them that they might want to travel together and split the cost. Attached to Licence.

New Undertaking: (a) The operator will advise the traffic commissioner of the type and registration number of vehicles used under that licence, and will advise of any changes — section 20(3) of the Public Passenger Vehicles Act 1981. Attached to Licence.

New Undertaking: (b) The operator will send in the original V5 document to the traffic commissioner, and will not use any vehicle without prior written approval from the traffic commissioner. Attached to Licence.

New Undertaking: (c) Each stretched limousine I novelty vehicle to be used under the licence will have a V5 registration book, and the operator must possess and produce, when asked to do so, a document confirming this.. Attached to Licence.

New Undertaking: (d) Each stretched limousine / novelty vehicle will receive a full safety inspection (maximum every 10 weeks) in premises suitable for the vehicle to ensure that its roadworthiness is maintained. Records of all inspections must be kept in accordance with the Guide to Maintaining Roadworthiness. Attached to Licence.

New Undertaking: (e) At no time will the stretched limousine carry more than eight passengers. Attached to Licence.

New Undertaking: (f) The operator will at all relevant times comply with the legislation in respect of the charging of separate fares and retain 12 months' evidence of compliance with this for each journey. Attached to Licence.

New Undertaking: (g) Drivers of stretched limousine will carry with them documentary evidence that separate fares have been charged for the current journey. Attached to Licence.

New Undertaking: (h) The operator will comply with sections 2 and 6 of the Transport Act 1985 with regard to local service registration and must be able to show compliance with these sections to VOSA, on request. This will include proof of payment of separate fares and either:

- Proof that passengers have travelled more than 15 miles. This will usually be evidenced by showing postcodes; or

- Proof that the service is an excursion or tour and falls outside the definition of a local service. Attached to Licence.

New Undertaking: (i) The operator will not use a vehicle that does not meet the ECWVTA standards or British construction and use requirements. Attached to Licence.

New Undertaking: (j) The operator will not use any vehicle where the traffic commissioner considers its use to constitute an illegal practice such as 'dry hiring' or purporting to operate under specious and irrelevant authority such as reference to schedule 6 or section 6 (which usually refers to construction and use provisions to allow the driving of a vehicle for private use — as opposed to hire or reward), in a effort to circumvent the operator licensing requirements. Attached to Licence.

New Undertaking: (k) If the operator seeks to use the 'tours and excursions' exception to the 15 mile rule, again this should be evidenced and readily available to VOSA. This may be on the booking form. The limits of the 'tours & excursions' exemption will also be fully understood by the operator, for example it cannot be available for more that six weeks. Attached to Licence.

New Undertaking: (l) The operator or driver will not break the alcohol laws. Attached to Licence.

New Undertaking: (m) The operator will provide an audit trail to prove to VOSA or any other enforcement agency, compliance with Passenger Service Vehicle requirements, namely. Attached to Licence.

When an application is sent to the traffic area office, a copy of all application forms and supporting documents must also be sent to each of the county councils and unitary authorities in whose area the service will operate. Failure to do so may delay acceptance of the application.

Some of the periods of notice applicable before the operation of registered services, including variations or cancellations, are at the discretion of the Traffic Commissioner. In such cases the application must be accompanied by a written explanation of why a short notice period is required.

Any registration may be inspected at the traffic area office in Leeds during public business hours. Copies of registrations can be sent by post or fax to any interested party upon prior receipt of a written request together with a fee of £3.00 per copy for posted copies or £5.00 per copy for faxed copies.
