**Item 2: New Equipment: Time Instruments UTP10 Accepted**

### **Item 5: Digital Tachograph Fitment to M1 / N1 vehicles**

Technicians are reminded that to fit a digital tachograph into category M1 / N1 vehicles first registered on or after the 01<sup>st</sup> May 2006 they **MUST** follow the guidance published in Special Notice 3-2009. If requested by a customer to fit a tachograph into this category of vehicle you must ensure that there is NO accepted mechanical solution available and the system is fitted in accordance with the tachograph manufacturer's information sheet.

**Important Note: This is a list of vehicles for which a mechanical adaptor has been approved by VOSA for the fitment of a digital tachograph. If a vehicle is not on the list, it does not mean that a digital tachograph cannot be fitted to that vehicle as the vehicle may already have been developed to have a digital tachograph fitted without the need for a mechanical adaptor.**

**If an operator has a technical concern / query regarding the fitment of these adaptors, then they should contact the supplier listed on the right, or the nearest Approved Tachograph Centre. The tachograph centres are made aware on an on-going basis of any newly approved vehicle/adaptor combinations.**
